Attorney McCormick spoke on the legal requirements included in the proposed Resolution 11-10.

James A. Ghesquire, President of Monroe Mold, Inc. spoke on their request. They are looking to build a new 8000 sq. ft. expansion to the existing building. They need to increase their size to meet customer demands as the business continues to grow. He mentioned that they have been a great neighbor and employer in the township. Members of the Board agreed. Tim Lake also spoke on the proposed Industrial Development District and how it would keep Monroe Mold, Inc. in Monroe Charter Township, since they are also looking at other locations.
