Consider authorizing the refund of \$8,000 Cash Escrow Bond to Tyrone Hudson for 15175 Oak Knoll Drive (property ID: 5812-500-186-00).

Trustee Barton spoke on her reasons for not wanting to refund the \$8000 cash bond to Tyrone Hudson. She stated that she refused to sign a check to refund the \$8,000 cash bond unless she was directed to by the board. She stated that she had requested that Mr. Hudson attend this meeting but he did not show up.

Attorney McCormick provided his legal opinion and provided reasoning on why he has recommended for the board to refund the cash bond. He also spoke the additional site improvement performance bond in the amount of \$8,000 that was provided to the Township last week for the completion of the exterior of the home and the surety bond in the amount of \$500,000 that was also provided to the Township last week by Mr. Hudson.

Building Official Mike Black addressed the issue and has recommended the cash bond be return to the home owner. He also addressed numerous questions from neighbors that were in the audience. In response to questions, he further stated that the state codes will be enforced for this property.

Treasurer Barton said she had investigated the issue of Mr. Hudson getting a loan for the completion of this house and doesn't believe he can complete the house for the \$75,000 he had previously mentioned.

Trustee Wilson was not feeling well and excused himself from the meeting at 7:46 p.m.

There was more discussion from members of the audience that opposed to the board refunding the \$8000 cash bond and one member of the audience wanted to see the motion changed to include the board adding more terms to the completion of the home.

Building Official Mike Black stated that the state building code addresses this subject and he will follow the code.

Clerk Schnurr stated that he had requested and received a written legal opinion from the attorney on this issue and if the legal terms of the paperwork he received for the cash bond escrow account has been met and if the surety bonds submitted were legal and enforceable. The legal opinion from the attorney recommended that we refund the \$8,000 cash bond and the surety bonds were legal and binding.
